- Helping develop and deliver courses for new technical officials
- Current JudoScotland board member responsible for safeguarding & anti-doping.

- Run my own successful business first as a franchise then a sole trader with 25 years of experience.

Knowledge, Skills and Abilities (Relevant to the position of Director)

I have served as a board member of JudoScotland since 2017. In these two terms I have has contributed to the strategic planning which has determined the direction of the business focus from 2017 to 2022, I have been a part of the Competitions Working Group (formed to grow and develop the delivery of judo events in Scotland). using my experience in being a Competition Controller I have helped deliver courses in timekeeping, competition recorder and the most recent senior recorders course.

I am the president of the Clyde Judo Club committee and have been since inception in 2009. Leading a team of coaches, parents committee and other volunteers, I have built and managed one of the biggest community clubs in Scotland, gaining official recognition through the inaugural iteration of the JudoMark club accreditation scheme, and three successful bids for delivery of a JudoScotland Grand Prix event for three-year terms. I have been instrumental in encouraging coaches and officials to take on their respective pathways, with various individuals reaching qualifications as referees, technical officials and UKCC qualified coaches. I am responsible for Clyde's team of eight active coaches.

In addition to roles within my profession and within Clyde Judo, I was involved with Active Schools delivering judo within primary schools pre-Covid and volunteered as Vice Chair of the Park Mains Community Sport Hub for several years, working with Renfrewshire Leisure to constantly develop and improve sporting provision to the region. I also worked as Floor Manager for the Birmingham Commonwealth Games 2022, responsible for a large team of volunteers delivering the Judo and Wrestling programmes, working closely with the Head of Sport to deliver a successful games.

As a driving instructor, I have been a registered sole trader for over 10 years. Prior to her sole trader registration, I operated my business as a franchise for fourteen years, regularly and consistently working with and maintaining a steady income from a transient client base. Additionally, I also have several years of experience working within the residential letting sector, handling paperwork for lease, repairs, enquiries, property viewings and delivery/return of keys.

Disposition and Personal Qualities

I am a hardworking and dedicated individual. Volunteering in judo for over forty years, I have helped to inspire and motivate generations of judo players, many of whom are still active as competitors, coaches, referees, technical officials and recreational members.

I have had to have resilience under pressure in delivering key judo projects such as the Birmingham 2022 Commonwealth Games, and volunteering as tournament director for the Scottish Open for over ten years among many other events, leading a large volunteer workforce each time.
