As a life long judoka and former member of both the Scottish and GB Judo squads, I bring first-hand experience of high-performance sport and a strong understanding of what it takes to succeed at all levels. Competing nationally, internationally and being part of 2 Olympic cycles (narrowly missing out on qualification) taught me discipline, resilience, and strategic thinking — values I've carried into my work as a coach, sport scientist, and business owner.

Since the age of 15 and now beyond retiring from elite competition, I've coached judoka from grassroots to performance level, gaining valuable insight into the needs of our community — from first-time participants to those aiming for national selection. From 2014 my work with "The Fighting Chance Project Scotland" has given me a valuable insight into the challenges that people with additional support needs face within not only judo but other aspects of life. Something I am proud of is to say this work saw me recognised and winning an award from Active Fife.

In addition to my coaching and sport science work, I run a martial arts and fitness facility, which has helped me gain skills in business management, financial planning, staff development, and community engagement.

Together, these experiences give me a well-rounded, hands-on perspective of judo in Scotland. I'm passionate about helping the sport grow, and I'd be honoured to bring my skills, energy, and commitment to the role of Director.
